MINUTES OF THE SOUTH SANTA CLARA COUNTY FIRE DISTRICT BOARD OF COMMISSIONERS SPECIAL MEETING FOLLOWED BY REGULAR MEETING OF October 9, 2019

1. CALL TO ORDER

The Special meeting of the Board of Commissioners of the South Santa Clara County Fire District was held on Wednesday, October 9, 2019 at Masten Fire Station. Vice Chairperson Lewis called the special meeting to order at 5:00 p.m. No new items or old business was discussed. The regular meeting of the Board of Commissioners of the South Santa Clara County Fire District was called to order by Vice Chairperson Lewis at 6:00 p.m.

4. MINUTES AND EXPENDITURES

4.1 Approve Board Meeting Minutes of August 14, 2019

5. BOARD, STAFF AND COMMITTEE REPORTS

5.1 Statistical Report of Incidents

Chief Crawford summarized the report provided for July and August statistics. There were 281 aid responses to the South Santa Clara County Fire District and the District provided 297 responses to other agencies during these months with the majority to Morgan Hill and Gilroy. The South Santa Clara County Fire District provided 280 responses to the City of Morgan Hill of which 267 were South County. Morgan Hill provided 121 responses over the 2-month period. There were 391 calls in the district over the two-month period of which 312 were medical in nature with a total of 1359 for the year in medical

Of the District's incidents, 80% were medical, 12% were fires/Struct. fire with 6% being vegetation fires and 2% public assistance.

5.2 Battalion Chief Response Statistical Report

Chief Crawford summarized the statistical report of Battalion Chief Responses within the south county for the months of July and August 2019.

BCs responded to 168 incidents during this period - 116 incidents were in the District, 2 in Gilroy and 50 in Morgan Hill. The BCs were on scene at 90 of those incidents, and on scene in less than 15 minutes 82% of the time.

5.3 **Inspector Statistical Report**

Craig Farley worked a total of 85 hours from June through July. There were 11 new inspections and 11 follow-ups. There were no complaints/referrals that required response from his office. 9 plan reviews were conducted during the reporting period.

5.4 Volunteer Firefighters Report

Company 70 volunteers had 12 hours of training. The volunteers had no incident calls. There are currently 8 active volunteers. The volunteers had 18 ride-along hours in the period. 21 candidates have been interviewed. Interviews were concluded Thursday, October 3, 2019. 10 new volunteers will be chosen from this pool of interviews. Calls went out on Monday, October 7, 2019 to provide DMV/EMT verifications. The program will be turned over to FAE/P Marshall by October 15, 2019 with 10 new members.

5.5 Mitigation Fees Report

There was one expenditure during the reporting period totaling \$26,220.32 for the UT Vehicle. Total fees collected were \$12,173.50. Revenues collected reflect fees for 24,347 square feet of various construction.

The balance of the mitigation fund is currently \$313,206.27.

5.6 Correspondence

6. OLD BUSINESS

6.1 Standards of Cover Study • Information

Chief Crawford reported Citygate has provided the final draft of the report to South Santa Clara County Fire District for review before the document goes to print. The City of Morgan Hill is working on a joint meeting. Chief Crawford will provide the meeting date when available.

6.2 Management Audit • Information/Action

9. CHIEF'S REPORT

Chief Hess reported Cal Fire is still at peak staffing. The Ballot Measure is still being discussed with County Counsel and is expected to go forward on the November 2020 ballot. Chief Crawford reported the yearly cost for County Counsel will change from \$15,000.00 per year to \$25,000.00 per year.
