5. Board, Staff and Committee Reports

- 5.1 Statistical Report of Incidents
- Chief Good reported that there were 425 calls within the District in July/August. The
 District responded to 292 calls to other agencies. There were 307 calls where other
 agencies responded to the District.
- The District responded into Gilroy Fire 10 times and 272 times to Morgan Hill.
 Gilroy responded into the District 98 times and Morgan Hill responded into the District 147 times.

5.2 Inspector Statistical Report

- Chief Good reported that Craig worked 91 hours August through September and Shawn worked 32 hours in September training. They performed 11 new inspections and 6 follow-up inspections. They handled 0 complaint/referrals, attended no training or meetings and performed 10 plan reviews. Craig final day was September 30, 2020.
- 5.3 Volunteer Firefighters Report
- Due to Covid 19 the Volunteers have nothing to report.

5.4 Mitigation Fees Report

During the August 1, 2020 through September 30, 2020 reporting period total fees collected were \$10,533.50. Fees collected reflect fees from 3 residence expansions, 4 garages, 2 detached storage units, 1 covered patio, 2 porches and 1 fire damage rebuild. There were no expenditures for the reporting period.

6.1 Financial Statements Audit - Information

Kathy Athey reported that the Draft Audited Financial Statements for FY 1920 were completed by Eide Bailly LLP. Final report will be available at the December meeting.

6.2 FY 20/21 Budget - Information

Kathy Athey reported that she is working with staff to modify the FY 20/21 Approved Budget. There were several GL accounts that need updating to reflect actual revenues and expenditures including grants, maintenance and the Calfire personnel costs. Santa Clara County will be financing the new engine that will be received later this fiscal year. Payments for principal and interest will be added to the modified budget.

6.3 Management Audit Report - Information

Chief Hess reported that the Board of Directors accepted the Management Audit Report and all recommendations at the October 6, 2020 meeting.

Commissioner Acker disagreed with some of the responses and inquired on procedure to update those responses. Chief Hess stated that the report was accepted as written and is part of the public record, but he will check to see if there is a mechanism in place for the Board of Commissioners to submit additional responses.

Item will continue to be on the Board of Commissioners agenda for future meetings and staff will provided updates on progress made on recommendations.

Chief Hess reported on the following:

SCU Complex:

SCU Complex is 100% contained

FSR was put on hold due to new emerging fires in October in LNU and SHU.

FSR will start again this Monday (400k acres) We have placed a large resource request.

Participated in many community meetings with the public.

Santa Clara Cattlemen's Association was instrumental in getting stakeholders together and gathering private landowners to ensure everyone was aware of the resources available.

Our Troops including District FF's have been working nonstop (55 days, 66 days with no days off)

Chief Hess met up with 3 of our S/T's last Thursday on the Glass Fire

Current Conditions

Red Flag Warning is in effect for many areas in Northern California with gusty winds and low humidity through Friday SCU has upstaffed in anticipation of this Red Flag Warning.

Santa Clara County OEM:

We have been working with Santa Clara County OEM Office and partnering with them on joint facility opportunities for home and landowners for post fire issues.

First Responder Fees:

First Responder Fees are solvent from the County and private ambulance provider (AMR/Rural Metro) through 2024.

Assistance By Hire

Ongoing with District equipment.

• Business Practice:

We are still running action items through County Council for determination for BOD vs BOC approval

County indicated that contracts up to \$225k would not need BOD approval

Audit Report:

E67

MH is paying for half of the maintenance for E67 (this needs to be formalized)

Consolidation: Partially agree (as it stated identify Options)

BOS decided to commission a 3rd party Consolidation study ensuring all parties, stake holders and the public are aware of the concept and available to be involved in this very complicated nuanced scenario. This is always a good idea to evaluate fire services and look for opportunities for efficiencies and ensure business practices for all agencies are understood.

All the Board of Commissioner's commended staff for all the work on the SCU Complex Fire. Many heard from local landowners and appreciated the outreach and updates during the fire. A huge thank you to all fire personnel for their hard work on the fire.
